Fees required by regulation 11 AAC 05.260

Permit to Appropriate Water

- **\$50** for one single-family residence or duplex, or for water use associated with one single-family residence or duplex
- **\$450** for up to 18 hours of staff time, for activities related to oil and gas and associated substances
- **\$450** for up to 18 hours of staff time, for activities related to locatable mining
- **\$450** for up to 18 hours of staff time, for hydroelectric power generation
- **\$450** for up to 18 hours of staff time, for water removal out of a hydrologic unit under AS 46.15.035 or 46.15.037
- **\$125** for 5,000 GPD or less for a use not listed above
- **\$250** for greater than 5,000 GPD for a use not listed above

Temporary Water Use Authorization

- **\$350** for up to 14 hours of staff time, for all uses of water from up to five water sources
